- c. **Restrictions on Use.** Customer use of AI Features is subject to the restrictions on the use of the Services set forth in the End-User Agreement, and the restrictions on use of AI Features in this section.

1. **No Use in High-Risk Applications.** Customer and its users will not use, and will not allow third parties to use, AI Features in a system or application where the use of or failure of such system or application developed or deployed with the use of AI Features

 5. **Other Prohibited Uses.** Customer and its users will not, and will not allow third parties to, use AI Features for: (i) surveillance in private places; (ii) facial recognition in public places or by law enforcement agencies; (iii) collecting or processing biometric information without the consent of the subject; (iv) falsely impersonating any individual; (v) conducting activities that infringe on or violate the rights of others; (vi) mining cryptocurrency; (vii) generating illegal content; (viii) facilitating fraud; (ix) violating any applicable law including, but not limited to, the E.U. and U.K. General Data Protection Regulation (GDPR), the California Privacy Rights Act, any other US state privacy law and any laws or regulations relating the use of generative artificial intelligence, as may be adopted and amended by relevant authorities from time to time.
